### \*\*\*\*\*REMINDERS\*\*\*\*\*

In case you or your dependents are in an automobile/motorcycle accident, you should check to make sure your automobile and motorcycle insurance policies are the PRIMARY insurance for medical expenses for injuries sustained in an accident and that your policy meets the Plan's minimum criteria for medical related expenses. The specific criteria can be found on pages 42 & 43 of the SPD (Summary Plan Description) booklet or please call the Plans Office at (732) 446-0394.

If you get DIVORCED, it's your obligation to promptly notify the Plans Office at (732) 446-0394 or email us at claims@local25plans.com within 60 days of the date of your divorce. Your former spouse's coverage will be terminated retroactive to the date of the divorce, and you will be responsible for reimbursing the Plan for any benefits incorrectly paid after the divorce.

Also please make sure to update your beneficiary! Contact the Plans office to request a new form to make sure your life insurance benefit and annuity/401K go to the right person!

If you have any questions regarding this, please be sure to give me a call at the NJ hall so I can assist you through the process. International's training center is also an option that I can walk you through, so just give me a call so we may discuss the process. Do you have a son or daughter who is graduating high school this year? Luckily for your child, Local 25 has the Stephen J. Leslie Scholarship Fund. Please call me for details and an application for them to complete!
